

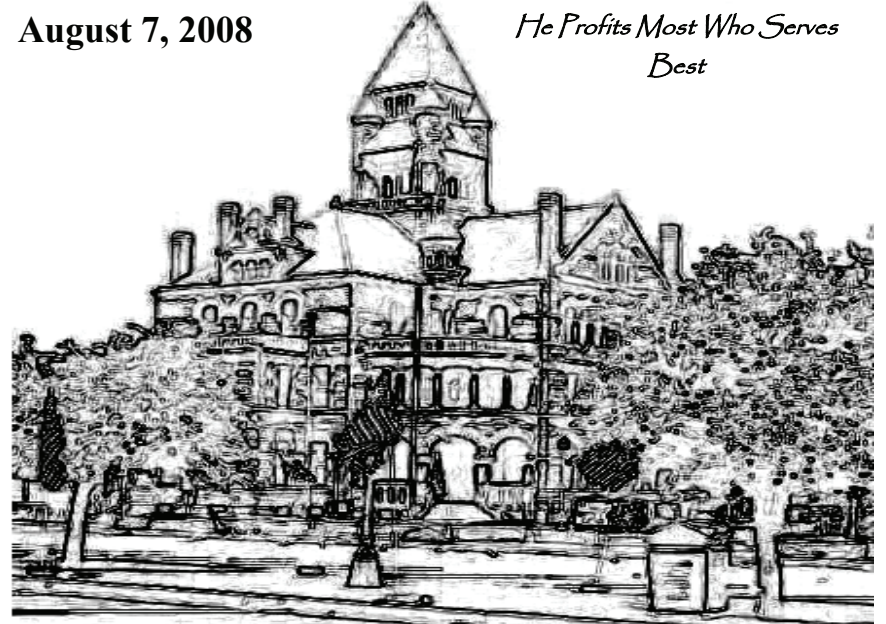

**FIRST.** The development of acquaintance as an opportunity for service;

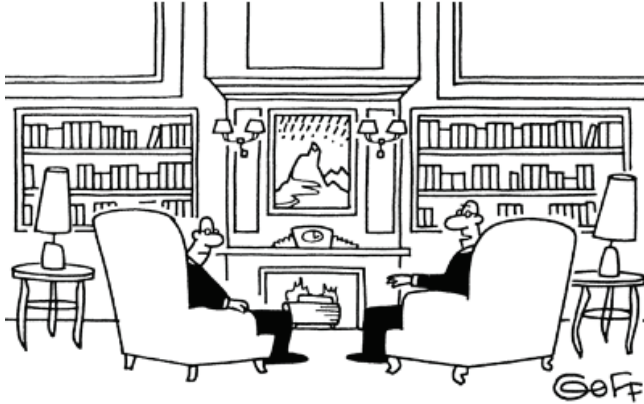
